#### **FROZEN PEACH DESSERT** **FROM: BETTY WEDDLE APT.#122**

- 2 cups Vanilla wafers (Crushed)
- 5 TBSP. Butter (Melted)
- 1 Bag Large Marshmallows (Use all but 10)
- 2 TBSP. Fresh orange juice
- 1 TBSP. Fresh lemon juice
- 2 Fresh peaches (Peeled & crushed)
- 1 Pint Whipping Cream (Whipped)

Mix crushed Vanilla wafers with melted butter. Press into bottom of 8x11 inch pan. Melt the marshmallows, orange juice, & lemon juice together. Cool slightly, then stir in crushed peaches. Fold in whipped cream. Freeze before serving.
